

OFFICIAL RULES AND REGULATIONS

SOCIAL MEDIA GIVEAWAY: The Mauldin and Me Giveaway (the “**Sweepstakes**”), sponsored by TAWANI Enterprises, Inc., and Pritzker Military Museum & Library (together, the “**Sponsor**”), will begin at 12:00 a.m. C.T. on June 7, 2021 and end at 11:59 p.m. C.T. on July 4, 2021 (the “**Sweepstakes Period**”). The winners (the “**Winning Entrants**”) will be selected at random and announced on July 8, 2021 (the “**Draw Date**”).

TO ENTER: The participant must 1) Take a “selfie” with at least one Mauldin ad located at these Chicago locations (105 S. Michigan Ave, 200 W Adams St, 1 S Franklin St., 50E Adams St, 60 S. State St, 104 S Michigan Ave 2nd FL).; and 2) fill out the brief form on <https://www.pritzkermilitary.org/mauldin-giveaway> to agree to the rules and regulations. All submissions must be made during the Sweepstakes Period to qualify. Alternatively, one may enter by mailing an entry form with participant’s first and last name, email address, address, and date of birth to: TAWANI Enterprises, 104 South Michigan Avenue, Suite 500, Chicago Illinois 60603. This method is also of no cost to the participant. Those entering by mail must complete the entry form with all required information for the entry to be eligible.

The prize for the third place Winning Entrant will be a T-shirt and book.
